



PUBLIC NOTICE

The Act Number 125 of May 7, 1942, better known as the “Puerto Rico Ports Authority Act” as amended, gives the Puerto Rico Ports Authority all rights to establish the following regulations:

- a. Regulation for the Use and Lease of the Property of the Ports Authority, which purposes to establish standards for the use and rental of the facilities owned by the Authority, as well as standardize the rules; define different concepts; determine the fees for the use and lease of facilities; establish procedures for requesting or renewing contracts; determine a consistent credit for improvements; establish compulsory leases and other clauses, according to approved at ordinary meeting of the Board of Directors of the Ports Authority, held on May 1, 2014, the Resolution 2014-024. By the foregoing, fulfilling and governed in all procedures with the provisions of Act No. 170 of August 12, 1988, it will be conducting a public hearing Wednesday, September 7, 2016 from 8:30 a.m. to 4:30 p.m. at the Las Olas Lounge, third floor of the Puerto Rico District Convention Center.
- b. Regulation of the Law Collection Per Gallon on Aviation Gasoline Importers to Operate at the Airports in Puerto Rico, which purposes to establish a uniform procedure that is applicable to all importers operating in all the airports in Puerto Rico, according to approved in meeting ordinary of the Board of Directors of the authority of the ports, held the 20 of February of 2015, the resolution 2015-004. By the foregoing, fulfilling and governed in all procedures with the provisions of Act No. 170 of August 12, 1988, it will be conducting a public hearing Thursday, September 8, 2016 from 8:30 a.m. to 4:30 p.m. at the Las Olas lounge, third floor of the District of the Puerto Rico Convention Center.
